Corlyn Altier was in attendance to provide a 2013 EMS Billing Recap. She also had the 2014 contract for signatures which had been approved at the 2014 Reorganizational Meeting.

## Reports

**Fiscal Officer Billie Dearlove** provided copies of the December 2013 bank reconciliation. She also provided a fund status report, and an appropriation status report. An EMS payroll register was also provided for December 2013.

**Trustee Robert Coleman** reported that the new pick-up truck had a recall issued and that the truck had been taken to the dealer and all items in need of attention were complete. Bob inquired as to whether Billie had received any information from Mike Smith regarding recording equipment. Billie had not so Bob will contact Mike again to get information on recording equipment for our meetings. Bob had also BP/Randy Smith of New Lexington, OH. Trustee Coleman indicated that January 10, 2014 was the end of the probationary period for Cheyenne Wells as fire chief. Discussion followed.

Trustee David Lyle reported that he had received calls from a resident on Twp Rd 390 regarding water running across the road. This will be investigated to see if we can determine where the water is coming from. It appears to be from the rental property of Larry McCartney. Dave would like to install an attic ladder in the township shop for easier access to the storage area. It was discussed and decided this was fine and Dave will purchase at Lowe's and have installed. Dave inquired as to why the township is cleaning up brush on Twp Rd 358. Trustee Coleman explained that he had been working with an economic development committee for several months and this is part of an attempt to bring more businesses to Thorn Township. Dave also asked for an update on the plaque for Dr. Rarick for the township complex. Billie is working with Magco and should have a proof of the plaque within the next week.

**Zoning Inspector Casey Casto** provided a zoning update and submitted his receipts and report for December 2013. Casey submitted copies of letters sent to residents of the township who were in violation of zoning regulations. The matter of cell phone reimbursement was again discussed and it was decided that the township will reimburse Casey \$38 per month for cell phone service. He also requested that the Trustees meet with the zoning board members to discuss and updates or concerns that anyone has. We need to declare the old medic and the old compressor as surplus so that the items can be sold.
