#### Reports

**Fiscal Officer Billie Dearlove** provided copies of the November 2014 bank reconciliation. She also provided a fund status report, payment register, receipt register and appropriation status report. An EMS payroll register was provided for November 2014. Billie reported that the Surface Tablet that was purchased crashed and had to be replaced by Microsoft. She also reported that the notes for the November meeting were lost and she requested the recording of the meeting in order to create the minutes. She will get these completed as soon as possible. Ads for part time road workers were ran in both the Beacon and the Perry County Tribune. Billie scheduled the 2015 Reorganizational meeting for Friday, January 2, 2015 at 5:00pm.

**Trustee Robert Coleman** reported that the time clock has been installed and is now being used. He also reported that resident Sharon Furnace on Twp Rd 493 requested that no snow be pushed in her yard this winter. Bob provided Scott Hill with an excerpt from the Township Handbook regarding authorization or lack of authorization of the Township to address flooding issues in the ditch by the new Dollar General store. Bob reported that the Village of Thornville had scheduled a meeting for December 29, 2014 to discuss the old fire house building and the lot beside it. He will report back when he hears from Beth Patrick.

**Trustee Richard Wilson** reported that the new salt water tank is still on order. Rick inquired as to whether we should consider hiring a full time road worker. This will be a matter for future discussion. Rick will get a key to the township meeting room and give to Ron Combs for the Legion meetings.

**Zoning:** Ed Corns provided a zoning update. He also submitted the zoning funds and report for November. Ed is checking with our Attorney to see if zoning meetings can be held quarterly instead of monthly due to low attendance.

**Fire/EMS:** Cheyenne Wells provided an update. Kyle Weekly and Andrew Selegue resigned from the fire department due to other obligations. He would like to add Brandon Thompson who was in attendance to meet the Trustees. Cheyenne reported that there is still a problem with water in the parking lot at the station and will have to be addressed in the spring.

**Motion:** A motion to approve Brandon Thompson as a part-time employee with the fire department was made by Robert Coleman and seconded by Richard Wilson. Votes were: Robert Coleman, Aye; Richard Wilson, Aye.

**Public Comment:** Ron Combs requested that something be done to repair the large holes in the road behind TC Market and in front of restaurant. We will send the road workers down.
